The validity of the passport must be more than 12 months upon submission of application for endorsement to Immigration Department. Hence, minim requirement of passport validity upon submission of approval stage is 14 months.	num
The passport must have a minimum of 6 consecutive empty pages.

Renewal Application
New letter from respective Embassy in Malaysia as Proof of Relationship is required for every renewal .
Passport Sized Photo
File upload requirements:
a. Photo must have blue background with photo size of 35mm x 50mm
b. Size of photo must be in 99 x 142 pixels
c. File size photo must be less than 20kb
d. File format must be in JPG or JPEG only
Please upload latest photo for renewal application
If Submit Separately:
i. SEPARATE submission from Principal/EP holder (common-law spouse/children/parents/parents in-law)
a. Copy of Identity (ID) page of the Principal/EP holder passport
b. Copy of a valid Employment Pass sticker (EP)/Approval Letter
ii. SEPARATE submission without either ONE of the parents in Malaysia (children ONLY)
Consent Letter either from a father/mother is required.
Copy of Employment Pass (EP) sticker OR any other valid pass of a father/mother in Malaysia
Copy of parent's Marriage Certificate/Divorce Letter
Personal Bond affixed with RM10.00 revenue stamp and endorsed by Inland Revenue Board (IRB) with payment receipt
Personal Bond : A bond required of a trustee, administrator, executor, guardian, conservator, or other fiduciary to protect against the loss caused by misconduct during the performance of the person A's duties.
Personal Bond must be stamped by Inland Revenue Board (IRB) and RM10.00 revenue stamp/e-stamping must be in coloured and signed by a Local Sponsor (Malaysian).
