



GUIDELINES ON ELECTRONIC SIGNATURE

(For MSC Malaysia)

1. INTRODUCTION

These Guidelines set out the minimum requirements to be complied with, if electronic signature ("E-Signature") is used for the submission of documents relating to MSC Malaysia Status to MDEC.

2. DEFINITION

E-Signature	has the same meaning assigned to it in the Electronic Commerce Act 2006 and includes a digital signature as defined under the Digital Signature Act 1997;
Company	refers to the company submitting the documents as specified in paragraph 3.1 to MDEC;
Signatory	refers to the individual authorised by the Company to sign the document for and on behalf of the Company.

3. REQUIREMENTS

- 3.1 A Company **may opt** to use E-Signature in the submission of the following MSC Malaysia Status related documents to MDEC:
- (a) application form in relation to matters pre and post MSC Malaysia Status;
 - (b) acknowledgement of receipt of document;
 - (c) acceptance of terms and conditions of approval letter or other document; and
 - (d) any other document allowed by MDEC from time to time,

provided that the minimum requirements as set out in these Guidelines are complied with and the use of E-Signature is not prohibited by any laws.


- 3.2 The Signatory must electronically sign the document **using any commercially available electronic signing software**, and the audit trail or signing report generated by the electronic signing software must be attached to the electronically signed document to be submitted to MDEC.
- 3.3 The Signatory must electronically sign the document using the **Signatory's own user account** for the computer, tablet, smartphone or electronic signing software, whichever applicable, with his own username and password. No document can be electronically signed on the Signatory's behalf, regardless of whether the Signatory has given his authorisation to do so.
- 3.4 The Company must ensure that:
 - (a) the means of creating the E-Signature is linked to and **under the control of that Signatory only**;
 - (b) any alteration made to the E-Signature after the time of signing is detectable; and
 - (c) any alteration made to that document after the time of signing is detectable.
- 3.5 The documents signed with E-Signature need to be **in acceptable quality** in terms of readability, visual resolution, and presentation.
- 3.6 In the event MDEC found the documents are **not in its original form and/or not meeting the acceptable quality or requirements**, MDEC shall have the right to **reject the submission and return the document to** the Company for re-submission.
- 3.7 The Company must maintain, or cause to be maintained, during the subsistence of MSC Malaysia Status, **such records relating to the compliance** with the minimum requirements as set out in these Guidelines and provide such records to MDEC if so requested by MDEC.
